Key Insights

Children and Young People (CYP)

The need for financial education, specifically financial literacy, has never been more important. The current climate which our CYP are growing up in is heavily focused on the cost of living crisis. This means our CYP are being exposed to financial strains at an early age and must be aware of how to handle this if they are to hopefully remove themselves from the poverty cycle.

How Charities Operate

It was identified that there are challenges around interactions between banks and charities/community groups. There is a need for banks to have a better understanding of the business model of charities and how they operate in comparison to companies

Asset Based Approach

Our county is rich with assets that can help us tackle local challenges such as the cost of living crisis. The knowledge and availability of these assets must be shared across our networks so that we can move towards an asset-based approach rather than a deficit-based approach. A preferred method of support is a collaborative approach that embeds our local assets to tackle local concerns.





Key Insights

Affordable Housing

The lack of affordable housing is a major concern for residents and local organisations in Buckinghamshire. Frozen welfare benefits, alongside private rental increases, have meant that our most deprived communities are unable to afford their homes, resulting in considerable debt. More social housing and an increase in welfare benefits is key if this situation is to improve for Buckinghamshire residents.

Pay Inequality


The pay gap between Voluntary, Community and Social Enterprise (VCSE) sector employees and non VCSE roles is widening due to organisations being unable to increase wages yearly with inflation. This exacerbates the effects of the cost of living crisis on those who are trying to help members of our community who need the most support. It is concerning that staff in the local VCSE sector may seek employment elsewhere as it becomes unaffordable to work for grassroots charitable organisations.

The 'Cost of Living Crisis Loop'

It has been highlighted that there is a repetitive cycle that involves the VCSE sector, philanthropy and grant making, which means we are not meeting the needs or demands of the community. For example, the COL crisis has meant a reduction in volunteering, a lack of resource and capacity, more frequent use of reserves and more funding applications, resulting in a squeeze on grant funding available.
